- Word limit: 2,000 to 3,000 words (exclusive of footnotes)
- Page Size: A4
- **Pagination:** The pagination must be done at the bottom of the page.

• **Citation Format:** Any uniform citation style can be followed. No particular citation style is required for submissions by school students.

• **Text Font:** Times New Roman; Font Size: 12 points; Line Spacing: 1.5.

• Footnotes Font: Times New Roman; Font Size: 10 points; Line Spacing: 1.

### **Submission Guidelines**

• Submissions shall be made in the online mode only.

• Submissions need to be original. Plagiarism shall result in disqualification.

• Co-authorship is permitted up to a maximum of two authors.

• Name and affiliation of author(s) shall be attached separately in mail. Any identification mark in the essay shall lead to disqualification.

• Essays submitted shall neither be published previously nor be under consideration for publication.

• Essays will be evaluated on the following criteria: relevance of the topic, depth of analysis, cogency of arguments, feasibility of suggestions, structure, language, and references in support.

# **Prizes**

The top three entries in the higher secondary category will be awarded the following cash prizes:

• 1st Prize: ₹ 10,000/-

• 2nd Prize: ₹ 5,000/-

• 3rd Prize: ₹ 3,000/-

The top three entries in the undergraduate category will be awarded the following cash prizes:
