Introduction to the Conference

Children constitute one third to half of the population in many countries. Poverty, malnutrition, lack of access to educational and health facilities continue to adversely impact the development of children. About 10 million children in India aged (5-14) are child laborers as per the 2011 census. According to WHO, in the year 2020, COVID-19 has disrupted the learning systems of 1.6 billion students in 190 countries. The situation was worse for children in conflict areas. Many Government run schools have severe shortage of teachers that lead to the drop out of students. Lack of basic sanitation facilities aggravates the plight of students, particularly girl students quitting schools. Child trafficking reportedly went up post pandemic. The Governments' inability to act on climate crisis is a violation of child rights. Many children have been forced to flee their homes because of war and climate crisis. The violence that they witness during war creates a long-lasting trauma unfolding a mental health crisis.

United Nations International Children's Emergency Fund (UNICEF) mandates that the countries must commit to ensure that every child has every right. United Nations Convention on the Rights of the Child (UNCRC) calls for care and protection of childhoods in the provisions of the treaty. Many NGOs have been instrumental in promoting this goal. With the passing of the Foreign Contribution (Regulation)Act, 2010 in India; many NGOs had to close their operations. In times of crisis and natural disasters, the NGOs do a considerable amount of work alongside the Government. During the COVID-19 migrant crisis, many NGOs in India worked for the relief and rehabilitation of the affected persons particularly Dalit and minority communities. It is in this context; we are organizing this International Conference on Global Care and Protection of Children: Issues and Challenges and soliciting articles on the themes mentioned.

This Conference aims to focus on documenting the stories of child rights on the themes of nutrition, poverty, education, health, identity, neglect of Government schools, sanitation rights, child abuse etc. We are particularly interested in papers discussing the impact of FCRA on child rights.

- Word limit for Abstract is 250-300 words.
- 3 to 5 keywords.
- Full paper should be between 3000-6000 words.
- Reference should be in Blue Book Citation Style (21st edition).
- It must be typed in Times New Roman, Font Size 12 on A4 size paper with 1 inch margin on all sides and 1.5 line spacing using MS Word.
- Full paper should be submitted on or before September 15, 2023.
- Abstracts / full papers have to be sent to mm_law@vignan.ac.in

Best paper will be awarded with a cash prize of Rs.2000 / 24USD / 21EUR

Co-authorship up to two authors is permitted and each author has to register separately.
