BIOGRAPHY OF JUSTICE LEILA SETH:

Leila Seth was born in October 1930 in Lucknow and was the first woman to top the London Bar exam in 1958. She joined the bar in 1959. In the same year she also graduated as an IAS officer. Upon topping the Bar in England, Seth was referred to as "Mother-in-Law" by a London newspaper, which carried a photograph of a young and attractive Leila Seth with her infant son, born only a few months before the exams. At the same time, other newspapers expressed their grief about how out of 580 students who took the Bar Exam, a married woman topped it.In 1978, she was appointed as the first woman judge on the Delhi High Court. In 1991, she was appointed the Chief Justice of Himachal Pradesh.

Justice Seth was also a part of various enquiry commissions, one of which was responsible for studying the effects of the television serial, Shaktiman (about a popular superhero) on children. Shaktiman was a popular TV series for children and it was the center of controversy because many children set themselves on fire or threw themselves off buildings hoping that Shaktiman would come and rescue them. Justice Seth was also part of an enquiry into the death of businessman Rajan Pillai, known as the "Biscuit Baron", who was found dead in police custody. She was also part of the Law Commission of India till 2000, and was responsible for the amendments to the Hindu Succession Act which gave equal rights to daughters in joint family property. She was also part of the judicial committee headed by J. S. Verma, a former Judge of Supreme Court, to suggest amendments to criminal law to sternly deal with sexual assault cases following the Nirbhaya case.

Leila Seth's autobiography was published by Penguin India in 2003. In *On Balance*, she talks about her early years of homelessness and struggle, her straying into law while in England with her husband Prem, and later practicing in Patna, Calcutta and Delhi; and her happy marriage of over fifty years, including the experience of bringing up three remarkable children: writer Vikram Seth, peace activist Shantum and film-maker Aradhana. Also dwelt upon are her views regarding corruption, discrimination and delay in the legal system; some judgments dealing with education and with inter-personal and constitutional law; and her experiences as a member of the 15th Law Commission.

The Concept of Judgment Writing has been prevalent for quite some time in the legal fraternity. A participant is encouraged to think like a Judge and reach a well-reasoned and innovative conclusion to render a suitable Judgment. The participants are expected to base their judgments on a thorough and diligent appreciation of the factual matrix. The competition encourages innovative judgments that have meticulously examined and applied relevant legal concepts.

Format of the Judgment:

- a) Cover Page: This page should consist of the following essentials:
 - Unique Participation Code (top right corner)
 - Name of the Competition
 - Name of the Court
 - Case Number
 - Name of the Parties: (for e.g., ABC v. Union of India).
 - Advocates appearing on the behalf of the Parties
 - *Note: Any hypothetical name, for the purposes of this point, could suffice.
 - Presiding Officer
 - Date of Delivery of Judgment

b) Body:

- Precise Facts of the Case
- Issues to be determined
- Arguments of the two Parties
- Statements of the Witnesses and Evidence Produced (if any)
- Analysis of the Arguments, Evidence and Conclusion based on the relevant facts.

c) Conclusion:

- Decision of the court based on the analysis of the law and evidence
- Reasons for the decision.
- Statement of the court on awarding of the remedy/order/Sentence.
- The Judgment was written and read over in open court on Date.
- d) The Judgment must be submitted as follows:
 - i. Language- English
 - ii. Page limit Max. 12 15Page.
 - iii. Page numbers bottom center

vi. The citation methodology to be followed is Bluebook (20th Ed.)

Evaluation Criteria:

Each Judgment shall be assed individually and independently by 3 Judges. Judges shall be from legal fraternity (Professors from esteemed institutions, Advocate or Retired Judge). Every draft will be marked on a maximum of 100 (one hundred) marks by each judge on the basis of criteria mentioned in the rules.
