- All submissions will go through similarity check in either Turnitin or Urkund.

- All the submissions must be sent to [acipr@alliance.edu.in](mailto:acipr@alliance.edu.in) along with the scanned copy of the declaration form provided under the submission guidelines. The subject of the mail should be 'Blog Writing Competition-23'.

- No submission will be accepted for the competition after the due date.

- Both author and Co-Author (if any) has to pay separately.
