ABOUT CRIME SCENE INVESTIGATION

- Crime Scene Investigation competition assesses the ability of students to perform procedures related to crime scene procedures and to identity the suspects.
- It helps to learn more about crime investigation by examining physical evidences from the crime scene along with use of reasoning and logical skills.
- It is interdisciplinary competition which involves identifying, reporting, sketching, identification, photography, reasoning and observational skills.
- It aims to increase knowledge of crime investigation through the examination of evidence found at the crime scene as well as the application of logic and reasoning.

TEAM ELIGIBILITY & TEAM COMPOSITION

The event is open students to any student pursuing the below mentioned courses in a recognized Institution are eligible to be a participant in this competition.

- Five year integrated law course
- Three year law course
- L.L.M

Each team shall comprise 2 members only and there is no bar as to the number of teams that may participate from the same institution.

RULES AND REGULATION

- All the participants are required to carry their own writing and drawing tools and exam board (one for a team).
- Participants shall be directed to the crime scene once they get acquainted with the plot.
- Each team comprising two participants shall be given maximum of 8 minutes to investigate the crime scene and note down relevant points.
- Teams can make rough sketches or graphs for their convenience during this time, Participants can analyze the crime scene and physical evidence by observing.
- Each team shall be required to record the observation in a given sheet and submit the investigation report. The Organizing Committee will provide Reporting Sheets.
- Each team shall be required to hypothesize the best possible story behind the incident and conclude the guilt of the suspect/s.
- Mishandling or Disturbing the crime scene property or communication with participants of other teams during the competition shall lead to disqualification.
- Participants are not allowed to touch or pick anything from the crime scene.
- A video will be played explaining the story of crime scene and followed to it participants will be taken to the crime scene setup.

(Participants should strictly adhere to this rule)

COMPOSITION OF THE REPORT

- Crime scene sketch with the labeling of relevant evidence.
- List of materials evidence found.
- A brief note about the relevancy of each material evidence.
- Hypotheses of guilt of Suspect/s and Reasons on which such hypothesis is based on.
- Conclusive story (In your opinion)
- Forensic analysis will play a key role Other observations and analysis as it seems to be relevant.
- Each team shall be given 30 minutes time for report writing after the completion of investigation and observation by the respective teams.

- The Mobile Phones for taking photo of crime scene shall be given by the organizing team. Any other use of Mobile phone shall lead to immediate disqualification of the team.
- Minimum of 2 and maximum of 5 pictures/sketches can be submitted by each team.
- Pictures/sketches related to the report shall be considered only if the report mentions the material so submitted.
- Further guidelines will be intimated on the day of the event.
- Results will be declared after evaluation of the reports by experts

FLOW OF THE COMPETITION

- Watching of the video clip which gives lead to the story line.
- Entry to crime scene.
- Interrogation session.
- Report drafting.
- The qualifying team shall move to the final round.
- The final round shall be the questioning session for the interpretation.

*DISCLAIMER

- The best and the nearest interpretation of the scenario with substantial evidence shall be the criteria for qualifying the round.
- The organizers has the full rights to amend the rules or the procedures at any point of time.
