Objectives of the Competition

To enhance practical investigative skills, promote teamwork and critical thinking, develop an understanding of forensic procedures, and provide an opportunity for students to apply legal principles in real-world scenarios. The competition aims to prepare students for the complexities of criminal law by simulating crime scene investigations and legal processes.



Who can participate? Eligibility

The event is open for the students of Law and Forensic Sciences discipline from various institutions/ Colleges/Universities.

Team Composition

- Each team shall comprise 3 members only (Law Mandatory)
- The team must consist of either 2 law students and 1 member can be specializing in forensics (or any relevant disciplinary) or only 3 law students can be participated.
- There is no limit to the number of teams that may participate from the same institution/ Colleges/Universities.

Winners
