REGISTRATION

I. ELIGIBILITY

- a. Students, enrolled in a full-time 3-year LLB or 5-year LLB programmes at a university, college and institutions that have been approved by the Bar Council of India are eligible to register in this competition.
- b. In accordance with the rules, the organizing committee will accept registrations on a *First-Come, First-Serve* basis.

II. GENERAL RULES REGARDING REGISTRATION

- a. The teams are required to show their interest by filling out the form in the QR code by 15th July, 2023.
- b. The participating team must email a scanned copy of the duly-filled Registration Form, Authorization Letter and Screenshot of the Payment Receipt to mootcourt.kjel@kristujayanti.com.
- c. Bonafide Letter from the respective college is mandatory: Registration shall be deemed ineligible in the absence of an authorization letter from the college.
- d. Participants are required to register as a team of 3 (2 speakers and 1 researcher)
- e. After registration, any modifications to the team detail form must be properly communicated to the organizing committee by email. Additionally, changes made during the competition will not be accepted.
- f. The Final registration, along with the fee of ₹3,500/- (without accommodation) or ₹4,000/- (with accommodation) shall be completed on or before 17th July, 2023.
- g. Teams that need accommodation will have to inform the host beforehand.
- h. Participants must follow all the rules outlined above and failure to do so may result in the cancellation of their registration and any subsequent claims relating to this will not be entertained.

MOOT PROPOSITION

Pandya Nadu is a Federal Republic with traditional values and culture and its agricultural sector forms the major part of its economy. Despite being an agrarian economy, Pandya Nadu has never shied away from the use of modern technology and has indulged in the promotion of innovations and creativity by always aiming and urging its inventors and creators to uncover the potential of their developments. Pandya Nadu is a signatory to the International Conventions and Treaties that mandate minimum protection for Intellectual Property Rights and has enacted laws to protect innovative and creative work.

Ms. Mandodari, born in Korkai Village in Sangam District of Dravida State in Pandya Nadu to Pulastya and Ketumati, was a curious and smart child who showed great interest in learning. Her teachers were amazed and surprised by her inquisitiveness to learn. After finishing her schooling, Ms. Mandodari joined one of the best engineering colleges in Pandya Nadu, 'Pandya Nadu Institution of Technology'.

However, to the surprise of her professors, Ms. Mandodari, being a brilliant student, chose to drop out of the college and started her own startup, 'Suryaloka' - a social networking application. The startup failed to gain momentum and popularity and, hence, had to be shut down. Ms. Mandodari then joined a company called 'Dasis' as an intern. Due to her extraordinary performance and deeper knowledge of machines and technology, she was offered to work as a part-time employee at Dasis. Ms. Mandodari with her innovative skills, took the company to greater heights, which promoted her as a partner and subsequently she became the President of the company at the very young age of 29 years.

During her tenure at Dasis, in the year 2020, Ms. Mandodari invented 'Agasthya', an Artificial Intelligence tool. The Artificial Intelligence (AI) tool was built to improve and evolve higher-level performance through algorithms. In the year 2021, Agasthya started to use Natural Language Processing (NLP) techniques such as Recurrent Neuronal Network (RNNs) or Transformer Models (TM) to perform its task. As Agasthya has continuously improved to become an autonomously operating neuronal network that is capable of generating new technical solutions and creativities without a predefined task that enables it to function unsupervised. Subsequently, over the years, Agasthya did not require instructions to be fed into its database. As a result of these technical advancements and the rolling out of premium versions, Agasthya is now able to compose music and write its own lyrics to its composition. Agasthya has also started using techniques like voice synthesis, voice cloning, voice mimicry and voice imitations. These methods entail developing a model based on a singer's voice. One of the voices used by Agasthya is of Mr. Karthikeyan, a world-renowned singer.

In order to launch Agasthya internationally and attract investors for the upcoming versions of the AI tool, Ms. Mandodari hosted a party where Agasthya performed a song never sung by Mr. Karthikeyan. The guests shared the performance by Agasthya widely on their social

media platforms, which quickly became viral online. In addition to creating the music for the composition, Agasthya also wrote the lyrics.

Soon thereafter, on January 10, 2023, Ms. Mandodari filed an application before the Appropriate Authority of Sangam district to protect the creative works of Agasthya. However, the appropriate authorities rejected the application stating that the author and performer can only be a natural person.

Aggrieved by the said decision Ms. Mandodari, appealed to the High Court of Dravida. The High Court of Dravida, upheld the decision of the Appropriate Authorities. Left with no other alternative remedies, Ms. Mandodari appeals to the Supreme Court of Pandya Nadu.

In the meantime, a civil suit for infringement was filed against Ms. Mandodari for copying the music composition of Mr. Isai Arasan by using AI before the City Civil Court of Sangam. The court issued a summons against Ms. Mandodari for her appearance. If all of this was not sufficient Mr. Karthikeyan filed a complaint under the Information and Technology Act, 2000 for the violation of his Right to Privacy. He accused Ms. Mandodari for intentionally allowing the AI tool to mimic his voice and perform it before her guests. The Laws of Pandya Nadu are in Pari Materia with that of the Republic of India.

ISSUES

1. WHETHER AGASTHYA, AN 'AI' CAN BE TREATED AS A LEGAL PERSON WITH LEGAL RIGHTS AND LEGAL OBLIGATIONS?
2. WHETHER AGASTHYA, AN 'AI' TOOL CAN BE NAMED AS AN AUTHOR UNDER THE COPYRIGHT ACT, 1957?
3. WHETHER AGASTHYA, AN 'AI' TOOL, CAN BE GRANTED PERFORMER'S RIGHT UNDER THE COPYRIGHT ACT, 1957?
4. WHETHER THERE IS A VIOLATION OF FUNDAMENTAL RIGHTS AND CAN IT BE CLAIMED AGAINST AGASTHYA, AN 'AI' TOOL?

Note: - The Participants are encouraged to add more issues.

- Disclaimer: - Unless otherwise indicated, all the names, characters, businesses, places, events and incidents in this proposition are fictitious and any resemblance to actual persons, living or dead, or actual events is purely coincidental.

STRUCTURE OF THE COMPETITION

I. DATE

The competition shall be held as a **Three Day Event** from 17th August, 2023 to 19th August, 2023 via offline mode.

II. COMPOSITION OF TEAM

- a) Each participating team shall comprise of 3 participants viz, 2 speakers and 1 researcher.
- b) The Participants may change their roles within their Team only with the prior intimation and approval of the Organizing Committee.
- c) No change in the composition of team members shall be entertained after the completion of registration.

III. RESEARCHER'S TEST

- a) Researcher's test will be conducted on 17th August 2023.
- b) The participant, who is registered as the researcher, shall only be allowed to participate in the Researcher's test.
 - The test shall be conducted after the Preliminary Round.
 - The test shall consist of MCQs and will be time-bound.
 - The participants shall bring no additional materials such as the Bare Acts, Memorandum etc. during the test.
- c) The score of the researcher's test shall not be considered for the overall total score of the participants. It shall be considered only for selecting the Best Researcher.

IV. PRELIMINARY ROUNDS

- a) Pairing of teams shall be done via draw of lots.
- b) There shall be exchange of memorials for all the rounds.
- c) Each team shall argue for both the sides in the Preliminary Rounds where each team will represent either the Petitioner/Appellant or the Respondent side.
- d) Each team will face a separate team and a separate bench in both the Preliminary Rounds.
- e) The time allotted for the Preliminary Round will be as follows
 - Each team will get 20 minutes.
 - Additional 5 minutes for rebuttal.
 - The division of time between the speakers is at the discretion of the teams subject to the maximum of 10mins for each speaker. The same shall be communicated to the court clerk in prior.
 - Extra time allocation will be solely at the discretion of the judges.

- f) Teams with the highest score in the preliminary rounds 1&2 shall qualify for the quarter-final round. In case of a tie, the team with the highest marks in the memorial shall qualify for the Quarter-final round.

V. QUARTER FINAL ROUND

- a) Eight teams with the highest score in the Preliminary rounds shall qualify for the quarterfinal round.
- b) The participants shall argue for any one side, which shall be decided on the basis of draw of lots.
- c) The quarterfinal round shall be Knock-out Rounds.
- d) The time allotted for the quarterfinal round shall be as follows-
- Each team will get 20 minutes
 - Additional 5 minutes for rebuttal to the petitioners.
 - The division of time between the speakers is at the discretion of the teams subject to the maximum of 10mins for each speaker. The same shall be communicated to the court clerk in prior.
 - Extra time allocation will be solely at the discretion of the judges.
- e) Only oral round scores shall be considered for evaluation; in case of tie, the team with the highest score in the memorial shall proceed to the Semi-Final Round.

VI. SEMI-FINAL ROUND

- a) A draw of lots shall be conducted to determine the pleading side for the Semi-final round.
- b) The time allotted for the Semi- final round shall be as follows-
- Each team will get 20 minutes
 - Additional 5 minutes for rebuttal to the petitioners.
 - The division of time between the speakers is at the discretion of the teams.
 - Extra time allocation will be solely at the discretion of the judges.
- c) The other rules shall remain the same as in the Quarter final rounds.

VII. FINAL ROUND

- a) The two highest scoring teams from the Semi-final round will advance to the Final round. The teams shall argue only from one side which will be decided on the basis of “Draw of Lots”.
- b) The time allotted for the Final round shall be as follows-
- Each team will get 25 minutes
 - Additional 5 minutes for rebuttal to the petitioners.
 - The division of time between the speakers is at the discretion of the teams.
 - Extra time allocation will be solely at the discretion of the judges.
- c) The other rules shall remain the same as in the Quarter final rounds.

ASSESSMENT CRITERIA FOR ORAL PLEADINGS

Maximum scores for the oral rounds shall be 100 points per speaker. The oral rounds shall be judged on the basis of following criteria:

GUIDELINES FOR THE MEMORIAL

- a) Each team shall prepare a memorial for both sides (Petitioner/Appellant/Respondent) in English Only.
- b) The teams must mail a soft copy of their memorials of both sides (Petitioner/Appellant and Respondent) in PDF Format for evaluation at mootcourt.kjcl@kristujayanti.com by 05th August, 2023 (11:59 PM) without fail.
- c) The file names of the electronic copies of the Memorials must contain only the team code and the side being represented in the following format: e.g. (for Team Code KJCLM 514) 514P/514A and 514R, “P/A” being for “Petitioner/Appellant” Memorial and “R” for “Respondent” Memorial.
- d) The teams should send four (4) hard copies of both sides of their memorials by 10th August, 2023 by post to the postal address provided in the brochure.
- e) The participants are required to bring a copy of the Memorial for their own reference.
- f) The participants are also required to bring two (2) copies of the Compendium for the judges and their own reference.
- g) The team should adhere to the Plagiarism rule of maximum 20%.
- h) The memorial must be submitted with the list of contents given below:
 1. Cover page
 2. List of Abbreviations
 3. Table of contents
 4. Index of Authorities
 5. Statement of Jurisdiction
 6. Statement of Facts
 7. Statement of Issues
 8. Summary of Arguments
 9. Arguments Advanced
 10. Prayer
- i) In the memorial or during the oral arguments, teams are not permitted to mention their names, the name of the institution or the name of any participant(s).

I. COVER PAGE

- a) The cover page of the Petitioner/Appellant Memorial should be **Blue** colour in A4 size sheet only.
- b) The cover page of the Respondent’s Memorial should be **Red** colour in A4 size sheet only.
- c) The cover page of the Memorial should clearly specify the representing side.
- d) The cover page of the memorial must have the following contents:
 - i. Name of the Court
 - ii. Case Title
 - iii. The Side of the Memorial
 - iv. Team Code (To be written on the top right corner)

III. ASSESSMENT CRITERIA FOR MEMORIAL

The maximum scores for the memorials shall be 100 marks. The memorials shall be evaluated on the following criteria:

SCOPE OF INTERPRETATIONS

Participants are not allowed to add any additional facts; they shall interpret the problem subject to reasonable conclusions.

CLARIFICATIONS

- a) The teams may submit queries or any clarifications regarding the moot problem during the prescribed period.
- b) All the queries must be mailed at mootcourt.kjcl@kristujayanti.com

PENALTIES

Failure to submit the Memorial within the stipulated time (soft copy)	1 mark for every hour that passes following the lapse of the deadline
Failure to submit the Memorial within the stipulated time (hard copy)	1 mark for every day post the deadline
Failure to adhere to the format of the Memorial	2 marks for each Memorial

ACCOMMODATION AND FOOD

- Accommodation facility would be made available (only to the participants) from the evening of 16th August 2023 to 19th August 2023 evening.
- Accommodation will be provided only to those who specify it in the registration form.
- Rs. 500/- will be is charged towards accommodation for three days. No refund in case the team is eliminated on the First day of the competition.
- Any damage caused to the property of the college or place of accommodation shall be borne by the participants and the same will be reported to their respective colleges.
- Food shall be provided by Kristu Jayanti College of Law. The other details shall be shared once the teams arrive.

MISCELLANEOUS RULES OF THE COMPETITION

- Upon completion of the Competition, the Organizing Committee reserves the exclusive right to use the memorials submitted to them as they deem appropriate.
- Participating teams should keep with them required study or reference materials for their own use during the oral rounds of Competition.
- Kristu Jayanti College of Law library can be used by the participants for reference purposes only by showing off the participation tag/badge given by the organizers.
- Scouting is not permitted in the competition in any of the rounds.
- **Ex-Parte proceedings:** If a team fails to report to the designated Court Room within the scheduled time in any of the rounds, the team shall be disqualified and the team present will be heard.
- The Organizing Committee reserves the right to take appropriate actions for any unethical, unprofessional or wrongful conduct during the entire period of the Moot Court Competition.
- The decision of the Organizing Committee shall be final with regard to any situation arising beyond the mentioned rules.
- The Organizing Committee is vested with the sole and absolute discretion to publish or not to publish the scores of any of the Oral rounds and Memorial scorecard.
- Absence during any round of the competition shall be reported to the college concerned.
- The Organizing Committee reserves the right to amend, modify or repeal any of the rules if so required and as they deem appropriate.
- Participating teams shall receive adequate notice of any/all such amendments or modifications to the rules and regulations.

CODE OF CONDUCT

All the teams are bound to follow the code of conduct and the rules laid down:

- Any behavior of indiscipline with the judges, organizing committee, student volunteer or any other staff member of the college, shall be dealt with strictly and may lead to immediate disqualification from the competition without the scope for appeal.
- Any attempt to approach the framer(s) of the problem(s) or the panel of judges of the competition, prior to the competition shall lead to immediate disqualification from the competition without scope for appeal.
- The rule of Contempt of Court will be followed and the decision of the Judges will be final.
- All or any grievances are to be presented only to the grievances committee or the organizing committee and the decision of the committees shall be the final and binding on the participants.
- Each team shall be assigned alphanumeric codes for the competition and the same shall be the sole source of identity for the respective teams throughout the competition.
- Intake / Use / Mere possession of any prohibited substances (like cigarette / alcohol / narcotic substances) is strictly prohibited during the stay throughout the competition, non-compliance with which, may lead to immediate disqualification and appropriate legal action.
- Teams entering / indulging in any kind of misconduct or violating the afore-mentioned rules and regulations will be disqualified.
