- 4. Article should be original (not published earlier or extracted from other sources) in English, 3000 to 4000 words (New Times Roman, font size 12, 1.5 spacing) including endnotes with proper citation.
- 5. Citation must be according to Bluebook 20<sup>th</sup> edition.
- 6. Articles having a plagiarism percentage exceeding 20% will not be acceptable.
- 7. Last Date of Registration is November 26, 2023.
