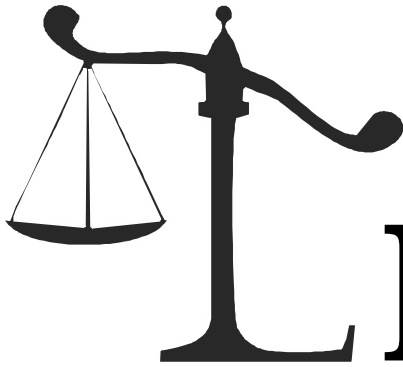

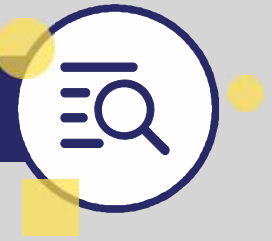

5. Bonafide students pursuing Five- or Three-Years LL. B Degree Course are only eligible. The students must be deputed by their respective colleges.
6. Participants participating in multiple events shall strictly adhere to the timings specified for each event. The organizers will not be responsible in case of clash of event timings.
7. Participants/ students must carry their respective college ID cards. Entry without the ID cards shall not be permitted.
8. Participants/ students shall not resort to or indulge in any unethical, unprofessional or immoral conduct. If found guilty, the organizers shall reserve the right to take appropriate action.
9. Participants shall bear their own travel and accommodation expenses.
10. The sole right of interpretation of rules and regulations and decision to disqualify in case of failure to follow rules and regulations on part of participating Team's will remain with the Organizers of this event.
11. Any grievance Will be settled by the Grievance Committee and the decision of the committee shall be final and binding.
12. The organizers are not responsible for the accommodation of the participants.

MOOT PROPOSITION

Samrat, situated in South Asia is an incredibly diverse and culturally rich country. It is known for its ancient history, geographic diversity and a population of over 1.3 billion people, making it the most-populous nation in the world.

Samrat is a land of diverse religions with Shrutism being the majority religion, constituting around 80% of the country's population. Istishanism is the second-largest religion in Samrat, making up approximately 15% of the population.

The caste system has had significant social, economic, and political implications throughout Samrat's history. Despite its legal abolition in the 1950s after Samrat's independence, its influence continues to have an impact on different aspects of society, especially in rural areas. Casteism continues to be a major social issue in various parts of the country.

To combat this caste-based discrimination, affirmative policies have been introduced such as reservation systems in education and employment opportunities for historically marginalized castes, known as Other Backward Classes (OBCs), Scheduled Castes (SCs) and Scheduled Tribes (STs).

Apart from casteism, poverty has been a longstanding issue in the country, affecting millions of people across various regions and communities. The Economically Weaker Section (EWS) was introduced as a category to address the economic disparities faced by citizens who might not fall under the traditional categories of Scheduled Castes (SCs), Scheduled Tribes (STs), or Other Backward Classes (OBCs) but still experience economic hardships.

These reservation policies have been a subject of debate and scrutiny. While they aim to address historical injustices and create more inclusive opportunities, some argue that they can create complexities in administration and might not always reach the most deserving individuals within the designated groups.

Karuna Pradesh is a state in the southern coastal region of Samrat. It is the seventh-largest state which makes up around 13% of the total population of Samrat and majority of the population of this state follow the religion- Istishan. This is the second-highest proportion of Istishans in any Samratiya state.

On July 22nd, 2023, the State Government of Karuna Pradesh issued the Karuna Pradesh Reservation of Seats in the Educational Institutions and of Appointments or Posts in the Public Services under the State to Istishan Community Ordinance, 2023. The Ordinance provided 5% reservation in admissions to educational institutions and appointments to public service offices in the State to the Istishan Community in Karuna Pradesh.

The State had moved the ordinance based on a report submitted to it by Karuna Pradesh Commission for Backward Classes (KPBC). The KPBC Report determined the social and educational backwardness of Istishans in the State.



The report submitted by the Commissioner highlighted that approximately 65% of the state's 6.4 million Istishan population were living below the poverty line, earning an annual income of Rs 11,000 or less. Additionally, 16% of this population had an annual income of Rs 44,500 or lower.

The government accepted the Commissioner of Minorities recommendation of a 5% reservation for the Istishan community.

On November 15th, 2023, the Karuna Pradesh State government replaced the Ordinance with the Karuna Pradesh Reservation of Seats in the Educational Institutions and of Appointments or Posts in the Public Services under the State to Istishan Community Act, 2023 (Karuna Pradesh Istishan Reservation Act).

Mr. Manohar Tamba, a public-spirited person and a leader of the opposing political party filed a petition before the Hon'ble High Court of Karuna Pradesh challenging the Karuna Pradesh Istishan Reservation Act on 10th January 2024.

The High Court held that the reservations were unconstitutional. They stated that the identification of the Istishan community in the state as a backward Class was based on unscientific and defective criteria. It further held that the identification of the entire Istishan community as a Backward Class on the sole basis of religion was unconstitutional.

On 15th March, 2023, the State of Karuna Pradesh preferred an appeal before the Supreme Court of Samrat challenging the verdict of the High Court. The Supreme Court granted a limited interim stay on High Court's verdict which allowed those persons who had already received admissions in educational institutions or were appointed to public appointments under the Act to continue receiving reservation benefits.

In another turn of events, On 10th July 2022, the Nihar government issued a notification to initiate a caste-based survey to collect data on socio-economic conditions to help create better government policies for disadvantaged groups.

Nihar, a state in eastern Samrat, is known for its rich history, vibrant culture. Caste discrimination is a deeply entrenched issue in Nihar, with marginalized caste groups facing various forms of discrimination in education, employment, social mobility, and access to basic amenities. The pervasiveness of casteism has hindered Nihar's social and economic development, perpetuating poverty and inequality among various caste groups.

The survey had two phases. The first phase was set to begin on 10th January 2023, with a house listing survey to count the number of households in the state. The second phase was designed to collect data related to castes, sub-castes, and religion. This was expected to take place between 15 June 2023 and 15 July 2023.

According to the first set of caste survey findings released by the Nihar government, backward classes, comprising other backward classes (OBCs) and extremely backward classes (EBCs), constitute 64% of



the state's population. The socio-economic data from the caste survey report that was tabled in the legislature on Tuesday, 34% of Nihar's population are "poor", which means their monthly income is below ₹6,000.

Depending on the caste-based survey, on 1st January 2024 the Nihar Legislative Assembly has unanimously approved the Nihar Caste Reservation Act, 2024, signalling a paradigm shift in the state's approach towards social inclusion. The bill proposes a substantial increase in reservation limits for Scheduled Castes (SC), Scheduled Tribes (ST), Extremely Backward Classes (EBCs), and Other Backward Classes (OBCs), elevating the quota from the existing 50% to an inclusive 65%.

The total reservation, including the additional 10% for Economically Weaker Sections (EWS), will effectively reach 75%. With this, 25% of seats remain unreserved, fostering inclusivity and diversity in educational institutions and job sectors. The move aligns with the state's socio-economic goals, recognizing the need for a more inclusive and representative system.

Previously, OBCs had an 8% quota, while EBCs held 12%. The proposed amendment significantly boosts these figures to 18% for OBCs and 25% for EBCs. Similarly, SCs witness an increase from 14% to 20%, and STs move from 10% to 2%. The changes reflect a comprehensive understanding of the population dynamics and the need for proportional representation.

On 6th January 2024, Akhil Lamba, a resident of Nihar, filed a Public Interest Litigation before the Supreme Court challenging the survey on the grounds that only the Union government can undertake a census, as per Entry 69 of List I of the Seventh Schedule. And that the Census Act of 1948 does not contemplate the caste-based census. The petition further challenges the Nihar Caste Reservation Act 2023 constitutional validity.

Supreme Court has clubbed both the above matters and referred the same to a Constitutional Bench. The matter is listed for hearing on 17th February 2024.

The Constitution of Samrat is *pari materia* with the Constitution of India and so are all other laws.

In the backdrop of the above problem following issues should be considered for the arguments.

1. Whether the petitions are maintainable before this Hon'ble Court?
2. Whether the Karuna Pradesh Istishan Reservation Act is constitutionally valid?
3. Whether the Nihar government is empowered to conduct a caste-based survey?
4. Whether the Nihar Caste Reservation Act 2023 violates the Basic Structure of Samratiya Constitution?



RULES FOR MOOT COURT COMPETITION

1. ELIGIBILITY, TEAM COMPOSITION

- a) Students pursuing Three Years / Five Years LL.B. Course from any law School/College /University in India recognized by the Bar Council of India (BCI) are eligible to participate.
- b) Law Schools/Colleges/Universities are entitled to nominate not more than two teams.
- c) Teams shall comprise of 3 members (two designated as MOOTER and one as RESEARCHER).

2. LANGUAGE, DRESS CODE AND CONDUCT

- a) The official language of the competition shall be English.
- b) Female participants are required to wear either a full suit comprising of black formal blazer and trousers, full sleeved white shirts or white kurta, black bottom wear, black blazer/ over coat with formal foot wear.
- c) Male participants are required to wear a full suit comprising of black formal blazer and trousers, full sleeved white shirts, black tie and formal foot wear.

3. REGISTRATION

Registration fees of Rs 2,250/- per team should be paid online

4. CLARIFICATION

5. MEMORIAL SUBMISSION

- a) Each Team must prepare memorials for both parties, i.e., the Petitioner and the Respondent. A soft copy of each side of the memorials must be e-mailed to the administrators (in PDF) at lawevent@lordsuniversal.edu.in latest by 15th February 2024 (18:00 hours IST) and the subject of the email should be "Submission of Memorials for Lex-Loci 2024.
- b) The file names of the electronic copies of the Memorials must contain only the team code and the side being represented (P for Petitioner & R for Respondent). E.g. Petitioner Memorial of Team Code-I should be named IP- Five hard copies of each side of the memorials (10 in total) must be submitted to the administrators latest by 17th February, 2024 (18.00 hours IST). The hard copies must be identical to the soft copy, else, disqualification would ensue.



c) Format of the Memorials

The Memorial shall be printed on only one side Of A4 size paper, with the following mandatory formatting specifications:

- 1 inch margin on all sides:
- Times New Roman typeface with 12 font size; and
- 1.5-line spacing.
- Citation style: Bluebook edition
- Teams shall cite authorities in the Memorial using footnotes.
- Explanatory or illustrative footnotes are not allowed. For footnotes, the formatting specifications are:
 - i. Times New Roman typeface with 10 font size; and
 - ii. Single (1) line spacing.
- The Memorials shall be spiral bound.
- The following color scheme shall be followed for the Cover Page of the Memorials: PETITIONER: BLUE and RESPONDENT: RED (The cover pages are already color coded in the sample memorial).
- The Arguments advanced shall not be in more than 20 pages.

6. PENALTIES

- a) Late Submission: 2 points for every 12 hours delay; disqualification after 48 hours.
- b) Incorrect filename: 1 point per file.
- c) Improper formatting: 1 points for each instance.
- d) Improper citations: 2 points.
- e) Exceeding page limit in argument advanced: 2 points per page.

7. EXCHANGE AND RETURN OF MEMORIALS

- a) There shall be an exchange of Memorials between the respective opposing Teams in accordance with the rules and regulations of the institution prior to all the rounds of the competition.
- b) The Teams are prohibited from making any marks on the exchanged Memorials and must return the Memorials to the administrators after each round.
- c) The Draw of Lots & Exchange of Memorials shall be conducted on 17th February, 2024.



8. ORAL ROUNDS

Rules of Oral Submission

- a) The time split between the speakers must be communicated to the Court Masters prior to the commencement of each Round. Once informed, these timings may not be changed.
- b) Delay in appearance for a round exceeding five (5) minutes will lead to the disqualification of the team for that round. In such a case, their opponent shall make their oral submissions ex-parte.
- c) Any Compendium of cited authorities may be submitted to the Court Masters prior to the oral pleading session. However, any further document may also be submitted during the proceeding, at the discretion of the bench.
- d) Use of any electronic device is prohibited during oral rounds.
- e) Team members may pass written material to the Orator who may be speaking, in a discreet manner without disrupting Court proceedings.

PRELIMINARY ROUNDS

- a) Each team might not have to argue from both the sides.
- b) Time limit for the oral submissions in this round shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.

Only one speaker from each team shall be permitted to rebut/sur rebut and team shall not reserve more than three (3) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the point of rebuttal made by the opponent team & upon the discretion of the Judge

QUARTER-FINAL ROUND

- a) Top eight teams will enter the quarter final round.
- b) Time limit for the oral submissions shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.
- c) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the sur-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.



SEMI FINAL ROUND

- a) Time limit for the oral submissions shall be thirty-five (35) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty (20) minutes for his/her individual oral submissions.
- b) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the stir-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.

FINAL ROUND

- a) Time limit for the oral submissions shall be forty-five (45) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty-five (25) minutes for his/her individual oral submissions.
- b) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than seven (7) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion Of the Judge.\

9. STRUCTURE OF THE ROUNDS

- a) Top eight (8) teams will qualify from Preliminary Rounds for the Quarter-final Round,
- b) Top (4) teams to qualify from Quarter-final Round to the Semi-final Round and
- c) Top (2) teams will qualify from Semi-final Round to the Final Round.
- d) The side on which a team will be arguing will be decided by draw of lots.
- e) In case of tie the memorial marks will be considered.

It is an event which focuses on the invaluable skills of interviewing, counseling and centers on a simulated law office interview. The main essence of the competition is to promote a healthy lawyer-client relationship.

Rules And Regulations:

1. Each college can send 2 teams of 2 participants.
2. The duration of the competition is maximum 15 minutes.
The problem for the competition will be given on the spot.
4. The participants are required to provide most suitable legal solution to the given problem.
5. Judges shall observe and evaluate you on how well you are able to counsel your client and offer him a practical solution to his problem.

Rules And Regulations:

1. Each College can send 3 participants individually.
2. Questions asked shall be based on Law Syllabus, Current Affairs and Legal General knowledge.
3. There will be three rounds: -
 - a) 1st Round - Fastest Finger First
 - b) 2nd Round - Visual & Buzzer Round
 - c) Final Round - Rapid Fire Round
 - d) Quiz shall be held in English only.
 - e) There will be no negative marking in Round 1 & Round 2.
 - f) However, the final round will carry negative marking of 0.50 marks for every wrong answer.



LEGAL DRAFTING

If you are a master in jugglery of words, then this is the contest for you!

Although mastering legal drafting skills takes time and practice, nevertheless, this competition would enhance your drafting skills. The participants must come prepared in topics like drafting a Suit, Writ Petition, PIL.'s, Written Statement, Conveyances such as Deed of Sale, Agreement of Sale, Lease Deed, Deed of leave & License etc.

Rules And Regulations:

1. The Acts relevant to legal drafting will be notified on 13th February, 2024 by 5.00 p.m.
2. The Draft must be submitted in English only.
3. Each college can send one team of maximum 2 participants.
4. The participants should bring their Own Bare Act's. NO books will be provided by the organizers.
5. Use of internet or books other than Bare Acts is strictly prohibited
6. The Petition/Application/Draft is to be prepared within 150 minutes (i.e. 2.30 hours)
7. Each entry shall be scrutinized by a panel of experts.
8. Special consideration will be placed on originality, applicability and feasibility of legal drafting, extent of research and most importantly the scope of the Draft.
9. All entries will be marked anonymously. Every team shall be allotted a team code after registering for the competition. The team members shall only use their code during the competition.
10. The participants are required to Draft as per the instructions provided to them.



APUD EXPLORATION

Legal research is an essential lawyering skill. The ability to conduct legal research is essential for lawyers, regardless of area or type of practice. The basic step is to find the leading case laws governing the issues in question. Therefore, case law studies are past legal decisions that help to investigate underlying principles of law applicable to the case in hand.

Apud (Latin-'in the writings or or 'reference to') Exploration conjures and tests a student's ability in techniques of legal research and analysis that forms an integral part of lawyering skills.

Rules And Regulations:

1. Each college can send only 2 participants.
2. In Round I, a brief description of 15 cases will be provided to each participant. They will be given 20 minutes to search for 15 cases. Then, they shall have to answer in the given round with name of the parties and three citations. Eight participants will qualify for the final round.
3. In case of a Tie-Breaker, facts in brief of landmark judgments shall be provided and the Teams will have to identify the name of the cases. No usage of internet will be allowed for this round.
4. In the Final round, 6 situational problems and 50 landmark judgments will be given and participants have to find which case law is relevant to which problem within 60 minutes.
5. Use of mobile phone or any reference materials is strictly prohibited.
6. A Computer with internet facility and access to google will be provided

TREASURE HUNT

Treasure Hunt challenge is a fun activity that includes general knowledge and legal questions, brainteasers and more. The event demands active and prompt use of skills and is sure to keep everyone busy.

Rules And Regulations:

1. Each college can send one team comprising of 3 members. Leaving the campus during the game is strictly prohibited.
2. Requirements for the events will be provided by the information desk i.e. pen and paper. No other requirements are needed for playing the game.
3. Each Team should announce a leader at the time of registration.
4. Each registered Team will get a unique identification number upon registration. Each Team leader should pin the identity card provided, while the Team is in action.



EXTEMPORE

Extempore is the art of public speaking that is carried out without preparation or forethought. It puts to test one's ability to think on the spot and also their spontaneity. Extempore is one such method which assists the students not only in thinking on their own but also in voicing their creative ideas with precision.

Rules And Regulations:

1. It is a solo event
2. Each college can send maximum 2 participants
3. Each participant shall speak for 2 minutes on the topic handpicked by them
4. A bell shall ring at the end of 2 minutes. Marks shall be deducted if they exceed time limit
5. The medium of language shall be English only.
6. Use of abusive language shall lead to disqualification.

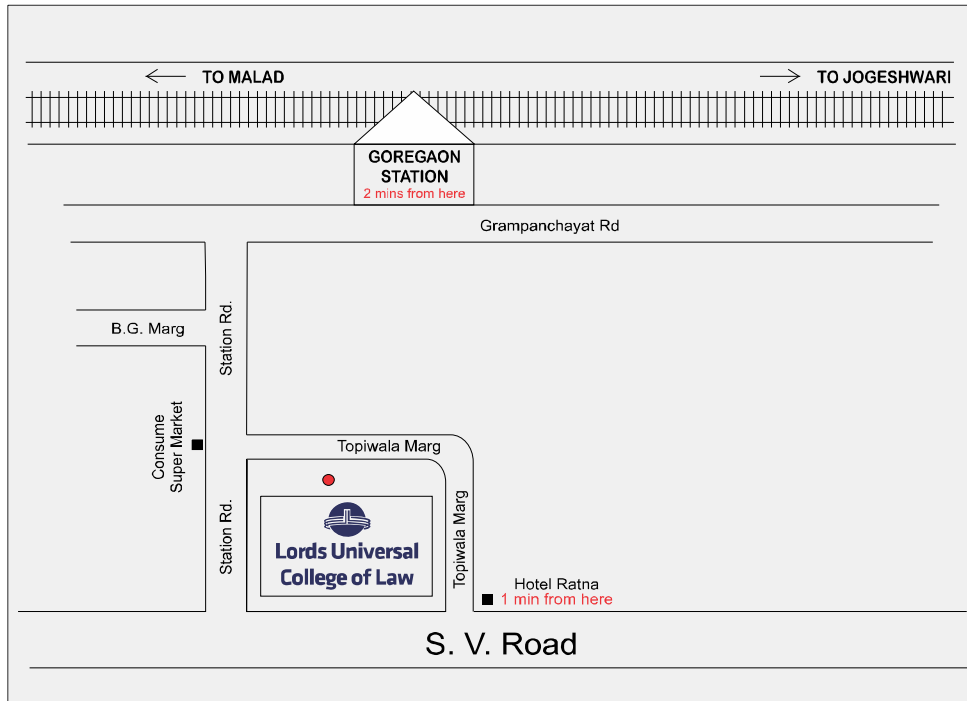
