### ABOUT THE COMPETITION

#### LANGUAGE

The video may be in **English** or **Hindi**.

#### JUDGING CRITERIA

- **Creativity:** Uniqueness and innovation in storytelling and presentation.
- **Legal Relevance:** The extent to which the video reflects a legal association and conveys a moral message.
- **Production Quality:** Overall video production quality, including visuals and audio, and Adherence to Guidelines

### RULES AND GUIDELINES

#### GENERAL GUIDELINES

- **Creative Freedom:** Participants are encouraged to reflect their creativity in content, presentation, animation, actors, and more
- **Duration:** The video length must not exceed 2 minutes.
- **Moral Message:** Each video must convey a moral message related to the legal theme.

#### REGISTRATION DETAILS

- **Registration Fee:** **INR 100** per member.
- **Eligibility:** The competition is open to all students pursuing LL.B. (3-year or 5-year course) or LL.M. from any recognized university across India.
- **Teams:** The team may consist of any number of members.
- **Entry Limit:** Each team is allowed only one entry.
