NATIONAL LEGISLATIVE REVIEW COMPETITION

No law is good law if it does not cater to the needs and requirements of the society and to cater to the requirements of the society, a law needs to be up to date. Therefore, the work of the lawmakers does not end with the enactment of a statute. Lawmakers need to make sure that the legislation is not outdated and reviewed time to time. For instance, the Indian Penal Code did not provide for offences such as molestation, acid attack, dowry death etc. which were added to the Code after it was properly reviewed in 2013. Moreover, review of a legislation is also necessary to ensure that the legislation is in consonance with the Constitution and has not become redundant with the passage of time.

There are several laws in India that are outdated and need to be reviewed immediately. Also, there are laws and prospective legislations which are claimed to be unconstitutional because of their provisions. The task of reviewing a legislation has not been taken up voluntarily by the lawmakers till now unless there is direction by the Supreme Court or an incident that urges the review of a legislation.

This competition aims to provide an opportunity to the students of law to interpret the below mentioned legislations, analyze them and prepare a provision for review of the legislation, suggesting which provisions are outdated and which provisions are contrary to the Constitution of India.

1. Citizenship (Amendment) Act, 2019
2. The Personal Data Protection Bill, 2019
3. The Transgender Persons (Protection of Rights) Act, 2019
4. Criminal Law (Amendment) Act, 2018
5. Finance Bill, 2019

Formatting Requirements

- The language for the competition will be strictly 'English'.
- The Page layout should be A4.
- The draft should be in Times New Roman in 12 font size. The Footnotes shall be in Times New Roman in Font size 10. A line spacing of 1.5 for the main text and 1.0 for the footnotes is to be adhered.

- Citation style must be uniform throughout the draft and the Bluebook 20th Edition citation must be followed.
- The length of the review should not exceed 7000 words.
- The cover page of the submission should include the Long Title of the Bill along with the name of the Participant(s) and the Team Code allotted.

NATIONAL LEGISLATIVE DRAFTING COMPETITION

Legislation is a typical connotation of politics and politics revolves around the polity, i.e. the people. Day in and day out, people sit in their homes, offices and even classrooms criticising the Government and the ineffectiveness of the legislations drafted by the Government. Everyone has the rational thinking required to draft a legislation and, therefore, it is essential that all the people come together like a think tank and draft the most effective legislation. Legislation is the primary source of law and the only effective way to implement the Rule of Law.

Drafting a legislation is an extremely onerous task and requires proficiency. It is usually difficult to express with exact precision anything that may be easily conceivable by mind. This is the skill of a legislation drafter who is expected to pen down every word with the exactness to create a nexus between the legislation and the intention behind it. Like goldsmiths, drafters have to give the most accurate shape to the statutes by the appropriate arrangement of words and punctuations. Even a great policy can turn out to be a bad law because of ambiguity or incorrect placement of words. Therefore, presence of mind is the key to a successful legislation.

Topic

Implementation of Two-Child Policy

Population, in India, has augmented drastically in the 70 years of independence and it is a big impediment in the development of the nation. To curb population, the Government is planning to adapt a two-child policy, according to which spouses with more than two children will not be allowed to serve in the Government. The policy is extremely vital and the Government also needs to ensure that personal liberty and Fundamental Rights of the people are not curtailed by this policy, vis-à-vis, amending the Constitution to implement this policy.

A separate legislation needs to be drawn to implement this amendment. For example, Indian Population Regulation Bill, 2020
